**S.R.O. (I)/2026.** - In exercise of the powers conferred by section 3 of the Petroleum Products (Petroleum Levy and Climate Support Levy), Ordinance, 1961 (XXV of 1961), read with this Ministry's Notification No. S.R.O.250 (I)/2016, dated the 24<sup>th</sup> March, 2016, and in supersession of its Notification No. S.R.O.971(I)/2026, dated the 05<sup>th</sup> June, 2026, the Director General (Oil), Ministry of Energy (Petroleum Division), Government of Pakistan, hereby determine, in respect of the petroleum products refined by all the refineries in Pakistan and imports specified in column (1) of the Table below, the rates of Petroleum Levy specified in columns (2), (3) and Climate Support Levy specified in columns (4) thereof, namely: -
