The Government of Pakistan through the Ministry of Energy (Petroleum Division) (DGPC) invites applications for pre-qualification of companies for bidding and marketing of Petroleum Blocks.

- 2. Interested applicants having experience in Bid Round Experience and In-house Proprietary Data and Tools should strictly comply with the following instructions:
 - i. A company may apply if it fills the criteria as provided in Annexure A (TORs) in the Documents.
 - ii. A company may apply in accordance with the Documents on the prescribed form attached hereto as Annexure B.
 - iii. Applications can be submitted by one company or a consortium of companies.
 - iv. Documents can be obtained from the office of Director General Petroleum Concessions (DGPC) 3rd Floor, Petroleum House, G-5/2, Islamabad on a written request or can also be downloaded from the website www.ppisonline.com.
 - v. Applications in a sealed cover clearly marked as

"Application for Pre-qualification of Companies for Bidding and Marketing of Petroleum Blocks".

The applications must be complete in all respects and submitted along with the requisite documents mentioned below and must be deposited in the Bid Box kept for this purpose in the office of the Director General, Petroleum Concessions at 3rd Floor Petroleum House G-5/2 Islamabad by 10:00 a.m. PST (Pakistan Standard Time) on May 10th, 2023:

- a. Application on the prescribed form (Annexure B)
- b. Evidence of juridical status of the company
- c. A copy of company's statute and Articles of Association.
- d. A description of company's organizational structure.
- 3. Applications submitted by all applicants will be considered as irrevocable and unconditional. In case any applicant states otherwise, his application will not be accepted and will be treated as "non-responsive".
- 4. Interested applicants can log-on to Ministry of Energy (Petroleum Division)' website www.petroleum.gov.pk or its consultant's website www.ppepdr.net and www.ppisonline.com to check the availability of relevant detail, if any.

5.	The applicants who comply with the aforementioned requirements will be considered
as	pre-qualified bidders for frame agreement with the Federal Government for Bidding and
Ma	arketing of Blocks. The successful applicants will be notified as soon as possible.

6. The Government reserves the right to exercise the powers to accept or reject any application. In the event of refusal to pre-qualify any company, the Authority shall as far as possible provide the reason thereof.
