

Moreover, Rs.300,000/- (Rupees Three Hundred Thousand only) as security fee (refundable) will be mandatory to be deposited through a cross cheque in favour of DDO, Policy Wing, during the execution / completion of agreement.

The EOI will be opened at 12:00 PM as per PPRA's rules and the closing time for submission of Tenders/Bids/EOIs is 11:30 AM on the same day.
